

TEACH Grant Overview and Checklist

Section A: Checklist

- Complete the FAFSA every year you plan to receive the TEACH Grant from the Department of Education (ED).
- Submit any documents or answer any questions requested by your Student Financial Services Counselor.
- Complete TEACH Grant [Counseling](#) each year you receive the TEACH Grant.
- Complete the TEACH Grant [Agreement to Serve or Repay](#) each year you receive the TEACH Grant.
- Agree to the Financial Aid Terms and Conditions which will be sent with the Financial Aid Offer each year.
- Maintain a 3.25 or higher cumulative GPA.
- Review the TEACH Grant page on [Studentaid.gov](#) for the most up-to-date information.
- Read the [TEACH Grant guides](#) and this form to become knowledgeable on the requirements of this grant.

Section B: Eligibility

TEACH Grant requires you to:

- Meet the [basic eligibility criteria for the federal student aid programs](#).
- Complete the [Free Application for Federal Student Aid \(FAFSA®\) form](#).
- Be enrolled as an undergraduate, post baccalaureate, or graduate student at a school that participates in the TEACH Grant Program. (You may receive TEACH a maximum of 4 years for an undergraduate degree and a maximum of 2 years for a graduate degree)
- Be enrolled in a TEACH-Grant-eligible program.
 - Northwest University's Bachelors of Education, Masters in Teaching, and Masters of Education programs are eligible for TEACH Grant. Stand-alone endorsements, Teacher Prep, and Pre-Requisites are ineligible. Student eligibility is on a case-by-case basis determined by your FAFSA, Agreement to Serve, completion of TEACH Counseling, and other factors as determined by ED.
- Meet certain academic achievement requirements (maintaining a cumulative GPA of at least 3.25). For specific information about the academic requirements for financial aid, contact studentfinancialservices@northwestu.edu.
- Receive [TEACH Grant counseling](#) that explains the terms and conditions of the TEACH Grant service obligation. You must complete counseling each year that you receive the TEACH Grant.
- Sign a TEACH Grant [Agreement to Serve or Repay](#) each year you receive the TEACH Grant.

Section C: Agreement to Serve

In exchange for receiving the TEACH Grant, you must agree to the following:

- You must serve as a full-time teacher for a total of at least four academic years within eight years after you complete or otherwise cease to be enrolled in the program(s) for which you received TEACH Grant funds.
- You must perform the teaching service as a highly qualified teacher at a low-income school or educational service agency.
- Your teaching service must be in a high-need field.
- You must provide ED with documentation of your progress toward completing your service obligation.
- If you do not meet the requirements of your service obligation, all TEACH Grants you received will be converted to [Direct Unsubsidized Loans](#). You must repay these loans in full, with interest charged from the date of each TEACH Grant disbursement.

Section D: High Need Fields

High-need fields are:

- bilingual education and English language acquisition,
- foreign language,
- mathematics,
- reading specialist,
- science, and
- special education, as well as
- any other field that has been identified as high-need by the federal government, a state government, or a local education agency, and that is included in the annual [Teacher Shortage Area Nationwide Listing \(Nationwide List\)](#).

If you plan to teach in a high-need field that is included in the *Nationwide List*, that field must be listed for the state where you teach either at the time you begin your qualifying teaching service or at the time you received a TEACH Grant.

How can I identify schools or educational service agencies that serve low-income students?

Elementary and secondary schools (public and private) and educational service agencies serving low-income students are listed in the annual [Teacher Cancellation Low-Income Directory](#). In addition, elementary or secondary schools operated by the U.S. Department of the Interior's [Bureau of Indian Education \(BIE\)](#) or operated on Indian reservations by Indian tribal groups under contract or grant with the BIE qualify as low-income schools.

Section E: Certification

As explained in the *Agreement to Serve*, each year you must provide ED's TEACH Grant servicer, [MOHELA Servicing](#), with (1) documentation showing that you have completed a full school year of qualifying teaching service, or (2) a certification that you intend to satisfy the terms and conditions of your TEACH Grant service obligation. The documentation of teaching or certification of intent must be submitted to MOHELA Servicing by an annual certification date.

Each year the TEACH Grant servicer, MOHELA Servicing, will notify you and tell you how to submit your documentation of progress towards completing your TEACH Grant service obligation, or your certification of intent to satisfy the service obligation.

If you do not submit your documentation of progress or certification of intent by the deadline given by MOHELA and do not respond to reminder notices from MOHELA Servicing, all TEACH Grants you received will be converted to Direct Unsubsidized Loans. You must then repay these loans to ED, with interest charged from the date the TEACH Grants were disbursed (paid to you). MOHELA Servicing will notify you if your TEACH Grants are converted to Direct Unsubsidized Loans.
