

## 2026-2027 Petition for Dependent Students without Parental Support

The law governing federal student aid eligibility for dependent students is based on the premise that the family is the first source of support and has primary responsibility for meeting the educational costs of the student. **In order to be considered for most types of financial aid, dependent students are required to provide parental information on the FAFSA** (Free Application for Federal Student Aid). The U.S. Department of Education stipulates that parent refusal to provide support or unwillingness to complete/sign the FAFSA, are not sufficient grounds to appeal the student's dependency status (this is true even if the parents do not claim the student as a dependent for income tax purposes, or the student demonstrates total self-sufficiency). In this case, the dependent student may be eligible to receive an **unsubsidized loan** to assist in funding their education (no other aid is allowed).

**If your parents have permanently ended all financial support or refuse to provide their information on your FAFSA**, you may complete this petition and submit your FAFSA without parental information, to be considered for a federal unsubsidized loan up to the annual grade level limits for a dependent student. If your parents are unwilling to complete and sign this petition, but meet the criteria above, you must include documentation from a third party (teacher, counselor, clergy member, court, etc.) who is familiar with your situation and can describe your relationship with your parents and possible reason(s) for refusal. This form will not be accepted unless all sections are completed. Once received, Student Financial Services will review your petition and make a final determination based on the documentation submitted.
