

## 2026-2027 Acknowledgement of Title IV Aid Eligibility

### Total and Permanent Disability (TPD) Discharge

**This form is not required if you are only seeking a Federal Pell grant.** If you have been granted a Total and Permanent Disability (TPD) discharge of your Title IV loans and/or TEACH grant service obligation, **you will not be eligible to receive a new Title IV loan or TEACH grant in the future unless:**

- You obtain a certification from a physician that you are once again able to engage in substantial gainful activity;
- AND –
- You sign a statement acknowledging that the new Title IV loan or TEACH grant service obligation cannot be discharged in the future on the basis of any injury or illness present at the time the new Title IV loan or TEACH grant is made, unless your condition substantially deteriorates so that you are again totally and permanently disabled.

In addition, the U.S. Department of Education monitors the status of borrowers who received a TPD discharge for a 3-year period\* beginning on the date that the discharge was granted. If a student requests a new Title IV loan or TEACH grant during the post-discharge monitoring period, they must resume repayment on the discharged loans **before** receipt of the new loan or TEACH grant. Borrowers must submit their TPD forms and track their progress to forgiveness on [StudentAid.gov](https://StudentAid.gov). We strongly recommend that you monitor your StudentAid.gov account for information relative to your particular TPD discharge application, its status, your rights, and your post-discharge monitoring period after TPD approval.

*\*Monitoring period does not apply to Veterans whose TPD discharge was based on a determination by the Department of Veterans Affairs that they are unemployable due to a service-connected disability.*

### Section A: Student Attestation and Acknowledgment Statement

Furthermore, if a new Title IV loan or TEACH grant service obligation is received during the 3-year post-discharge monitoring period described earlier, I acknowledge that collection activity will resume on any previously discharged loan and I will once again be subject to the terms of the TEACH grant service obligation (if applicable).
